NORTHWEST TERRITORIES TREATY NEGOTIATIONS

UPCOMING MEETING DATES:

September 5/6 - Vancouver

NOTES FROM MOST RECENT MEETING – VANCOUVER (JUNE 19 & 20/18)

ADKFN presented to Canada and Northwest Territories new negotiation positions on the following matters:

- <u>Municipal Governance</u>
 - ADKFN is still trying to get the required information from the GNWT to assess whether they are going to pursue a public model of governance and to calculate the resource royalties within the traditional territory of ADKFN. The lack of sharing information resulted in ADKFN giving notice to Canada and GNWT to cancel the July meetings that were scheduled for Yellowknife. A letter was sent to both Canada and GNWT expressing ADKFNs disappointment and frustration in providing information that profiles the land and resources within the Settlement Area broken down into categories that include particulars on existing tenures, royalty payments on tenures, shapefiles and particulars of contaminated sites, and metrics on the forestry and oil and gas sector; and a profile of the Hamlet of Fort Liard broken into categories that include complete budgets and financial statements, certified assessment rolls, mill rates, and the 2014 Formula Funding Review Report.
 - ADKFN's objective is to pursue a model that is financially viable, efficient and provides the highest level of services to ADKFN's community.
 - ADKFN has sought funding from the Government of Canada to complete a Municipal Incorporation Study & Boundary Review for the Hamlet of Fort Liard - Important tasks to be covered in the completion of the Municipal Governance Study / Municipal Incorporation Study and Boundary Review for the Hamlet of Fort Liard will include the following:
 - Detailed Review of existing Hamlet budget, capital expenditures and municipal financial statements;
 - Completion of an economic analysis of current operations and governance of the Hamlet;
 - Assessment of existing Hamlet infrastructure (i.e. Infrastructure Deficit) and projection of lifecycle maintenance and capital upgrades;
 - Review of existing funding programs and block transfers from GNWT and Canada;
 - Assessment of existing service delivery models in the Hamlet;
 - Review of potential boundary extensions to improve assessment base and taxation options;
 - Detailed assessment of most viable taxation model;
 - Professional recommendation(s) with respect to potential amended incorporation of Fort Liard; and
 - Get all other technical municipal infrastructure reviews and forecasting

- <u>Tax Arrears</u>
 - While not traditionally a treaty negotiation item, the matter is being discussed at the Main Table Negotiations with the GNWT because it is creating anxiety for ADKFN's members. This is one part of the larger set of issues that needs to be resolved. ADKFN wants to clear the air on who is responsible for tax and holds the view that ADKFN is not responsible and has never had tax jurisdiction over the Hamlet; this is GNWT's responsibility. The simple point is that ADKFN does not want to take over the Hamlet with any tax liabilities. ADKFN wants to have a clear path to resolve this issue. GNWT has expressed that this isn't a negotiating issue from their view and that they encourage ADKFN to continue to do what they are doing and pushing it up to the Minister to resolve. GNWT did concede that is an item that affects the transfer of the Hamlet if public governance is selected by ADKFN. In the Tlicho context, the GNWT accept that debts owed were not transferrable to the new government.
- <u>Capital Transfer/Core Cash Benefits</u>
 - Considering recent settlements with Canada, ADKFN is concerned that the previous negotiation team was in acceptance of Canada's offer. The current council is not in acceptance of Canada's offer and is seeking more in capital transfer/core cash benefits. ADKFN presented the rationale to Canada why they believe the transfer should be greater than the existing 16 million (plus inflation adjustments). Discussion involved the recent adjustment made to Dehcho and what the proportionate share would look like for ADKFN.
- Land Quantum
 - ADKFN is not in acceptance to select a % of the lands within the Yukon and/or BC to offset existing interests in NWT. Present discussions have included that ADKFN wants to set aside the NWT lands and then it will deal with Yukon and BC separately that it won't be packaged together.
- <u>Taxation</u>
 - ADKFN has presented that they want the taxation of all interests within their traditional territory in NWT. Information to the value of that taxation is still needed. GNWT is opposed to that negotiation position.
- <u>Phasing Change Consideration</u>
 - Negotiation discussions have considered the elimination of phasing the implementation and moving up the "social envelope" from Phase 2 to Phase 1 of Implementation specifically community wellness, health, education, justice and social program support

Other related activities already established and being worked on in association with the <u>Negotiations for Self Government:</u>

- Loan Forgiveness and the impact on ADKFN since they were fiscally responsible and do not take out loans for negotiations in the past. Consideration must be given to compensate ADKFN for that practice since other First Nations took out excessive loans and if they are being forgiven then effectively they are receiving more per capita in treaty settlement when you include in the entire package the historical loans
- Development of a Table Management Plan
- Development of 2018-2019 Work Plan
- Development of a new Election Code
- Development of Pre-Implementation Plan
- Development of a Land Use Plan with consideration that it is must be consistent with the Dehcho Land Use Plan. A meeting of the Dehcho Land Use Committee and ADKFN is to occur in August in Vancouver
- Conducting a Governance/Incorporation Study for the municipality
- Engagement with other First Nations for overlap discussions to resolve outstanding issues
- Development of Human Resources Plan and Policies

Other items being planned for development depending on funding status:

- Development of a Constitution
- Development of a Financial Management Plan and fiscal policies
- Development of a Financing Agreement
- Development of an Economic Development Plan and Fund
- Specific Claims research

DISPUTE WITH PARAMOUNT – POINTED MOUNTAIN AND KOTANEELEE

ADKFN has sought legal representation from Rae and Company (Rae & Co) to manage the file concerning the failure of Paramount to honor benefit agreements (BAs) related to activities occurring in Northwest Territories (Pointed Mountain) and the Yukon (Kotaneelee). Currently ADKFN has sought for the MVLWB and GNWT to aid in having Paramount to honor those relationships. Failing either assisting ADKFN then consideration by ADKFN will be whether they wish to proceed with litigation against Paramount.

DISPUTE WITH JAYHAWK RESOURCES

ADKFN has sought legal representation from Donovan & Co to manage the file concerning the claim that Jayhawk should be compensated for a 2009 Consultation and Participation Agreement that was signed by former leadership. The agreement basically asserts that Jayhawk would get 10% interest in existing and future leases of the lands for which ADKFN is negotiating as part of its land claim. Jayhawk is claiming they met their obligations and therefore is entitled to 10% of their interests.

LANDS AND RESOURCES

EVENTS

The following workshops and meetings were attended by Lands and Resources representatives in June and July:

- PRA-OGOA Conference call: Landmark attended the Petroleum Resource Act- Oil and Gas Operations Act meeting on June 12, 2018 via conference call.
- ADKFN Implementation Group Meeting: Landmark attended the implementation working group meeting in Yellowknife on June 11-12, 2018;
- Lands Working Group Meeting: Landmark attended the treaty lands working group meeting on June 13, 2018 via conference call;
- ADKFN Internal Meeting: Landmark attended the ADKFN Internal meeting held on June 25, via conference call;
- Mineral Resource Act (MRA) Meeting: Landmark attended the *Mineral Resources Act* meetings on July 4-5, 2018 via conference call;

REFERRALS/CONSULTATION

- A referral response was sent to the Mackenzie Valley Land and Water Board regarding Prairie Provident Resources' new Land Use Permit for abandonment and reclamation activities (MV2018X0002).
- A referral was received for Paramount Resources Ltd. regarding 2017 Annual Progress Report (MV2014X0011). The Progress Report outlines remediation activities carried out during 2017 at the former Pointed Mountain Gas Field, located approximately 30 km NE of Fort Liard in NWT. ADKFN leadership initially expressed concern over submitting a referral response as the site is part of a dispute with Paramount regarding its failure to honour the commitments outlined in the impact benefit agreement and the company's remediation plans. Landmark withheld the referral submission as directed by ADKFN leadership until they had

consulted with legal counsel. Landmark then submitted the referral response (after the deadline) to the Mackenzie Valley Land and Water Board following approval from ADKFN leadership.

- Call with EnviroSearch: Landmark had a phone conversation with Margot Ferguson from EnviroSearch regarding the proposed abandonment and reclamation activities by several proponents in the Fort Liard area.
- Call with Terence Hughes: Landmark had a phone conversation with Terence Hughes from Paramount regarding the pre-engagement and notification of a land use permit referral for former well sites near Fort Liard.
- Referral Response Template: Landmark had a conference call with Boyd and Hana regarding a refined strategy for responding to referrals within ADKFN traditional territory.

FUNDING APPLICATIONS

• IRMA Resource Pressures Funding: Completed and submitted the application for 2018/19 IRMA Resource Pressures Funding. This supplemental funding was applied for to help cover the costs of legal support and high-level consulting services required for certain projects currently occurring in or immediately surrounding ADKFN traditional territory (Canadian Zinc- Prairie Creek Mine, Paramount Resources Pointed Mountain Remediation Site, Borealis Geothermal Project). Due to a high volume of submissions and Nations that were deemed by IRMA staff to be in greater need, ADKFN did not receive this funding from IRMA.

RESEARCH APPLICATIONS AND ARCAHEOLOGICAL PERMITS

One research application has been sent to ADKFN since the previous Band Member update (ADKFN and Landmark have responded applications received outlining any comments or concerns):

- Groundwater Monitoring in the Liard Basin- The University of Guelph in collaboration with the Department of Environment and Natural Resources (ENR), Government of the Northwest Territories and the University of Calgary is applying for a land use permit for a groundwater monitoring program near Fort Liard. Landmark reviewed and summarized the research proposal, provided recommendations, and submitted to ADKFN leadership for review, response, and signature.
- Three archaeological inspection permits from within the NWT have been sent to ADKFN since the previous update; however, all permits fall outside ADKFN's traditional territory and therefore a review and summary with comments was neither required nor submitted to ADKFN.

LAND USE PLANNING

• As stated in the previous update, Landmark continues to work with Urban Systems on an independent ADKFN Land Use Plan. Community engagement on the plan is scheduled for the upcoming Fall. The plan will set out economic, ecological, and cultural priorities and policies for ADKFN land management and the land selection component of treaty negations. The federal government has committed

funds for Phases 2 and 3 of the plan, but this is inadequate to also cover the implementation of the plan. Additional funding for the plan is being sought via a proposal to the federal government.

DEVOLUTION

Mineral Resource Act discussions continue as part of the Devolution process. Landmark attends *Mineral Resource Act* meetings on behalf of ADKFN to ensure ADKFN's participation in the devolution process and the development of resource management legislation and policies.

TRANSITION INTERNALLY OF RESPONSIBILITIES FROM LANDS AND RESOURCES TO COMMUNICATIONS

In the past year, consultants have primarily been responsible for representing ADKFN at consultation meetings with various levels of government. As ADKFN builds capacity, the intent is to transfer these responsibilities from Lands and Resources to Communicate as technical aptitude permits. In the process, Landmark reviewed all the meetings, conference calls and workshops it attends on behalf of ADKFN. Going forward Landmark will provide instruction and mentorship to the Associate of Communications when necessary as he transitions into his new role as ADKFN's representative.

BAND OFFICE HAPPENINGS

ADOLESCENT PROGRAM AT THE GATHERING PLACE (FORMALLY THE TREATY HOUSE) – A UPDATE FROM THE PROGRAM

- We are pleased to welcome Holly Fantasque who has accepted a part-time position in this program. She will be working every Monday, Wednesday and Friday evening.
- The new hours of operations are working out well. We are now open Monday Thursday from 4 p.m. 10 p.m. and Friday's from 4 p.m. 11 p.m.

COMMUNITY JUSTICE

- The Community Justice Program continues to work with our local RCMP Department and Crown attorney's office for community members of Fort Liard.
- Recently the RCMP and Community Justice Program held a bike Rodeo for youth. Helmet fitting, obstacle course, and bike safety were reviewed. Lots of prizes and certificates were given to the kids that participated.

LANGUAGE/HISTORY REVITALATION PROGRAM

- If you have any suggestions on ideas for this program please forward them to Jacqueline or Kathy at the office.
- We are in the process of coordinating Slavey language classes for adults wanting to upgrade or refresh their language skills. We hope to have this up and running by September.

TRADITIONAL SEWING GROUP

- The community Traditional Sewing Group has been shut down for the summer months and will be starting back up in the Fall.
- We will notify community members via our Facebook Page and Community Postings.

COMMUNITY WELLNESS

- We began unfolding our programs and workshops in full force as of June. We are providing the services that the community requested. These are being coordinated by Michelle Browning and Robert Loe.
- Please see the attached schedule of events for August. Be sure to come to the band office and check the bulletin boards for activities or our Facebook Page.
- We are offering A.A. every Wednesday night at the Gathering Place. This is being hosted by Dennis Nelson and or Jacqueline.
- We were able to provide the students graduating high-school this year with laptops. We are proud of the individuals that have chosen to continue forward with their education in college. We wish them much success.

HEALING ON THE LAND

- This is a new program for individuals to access.
- This program offers a 28-day healing program, it also offers a 1 week program and a weekend program.
- Individuals are required to leave the community and heal on the land.
- This is aimed to help people with addiction problems.
- We are currently seeking individuals that are willing to rent us their cabins.
- We are seeking Elders that are willing to help these individuals.
- Honorius is paid to Elders and for cabin rentals. If this is of interest to you, please contact Jacqueline at the band office.

ELDER'S COMMITTEE/YOUTH COMMITTEE

- We are still seeking individuals to be a part of these committees. The voice of these committees will be heard. Concerns brought forward from these committee will be brought to the attention of Chief and Council. Together solutions can be found, and community member voices are heard.


